# PROPOSED 2020 E-SPLOST RENEWAL

### E-SPLOST OVERVIEW

- Provides school districts the funding needed for the renovation and modification to existing facilities and the construction of new schools.
- ▶ This referendum allows for a one-cent (or 1%) Education Special Purpose Local Option Sales Tax (E-SPLOST) for the funding of capital outlay projects.
- Funds can be used for:
  - Specific capital improvement projects for educational purposes (e.g. buses, construction, technology, etc.)
  - Retiring General Obligation (GO) Bond debt incurred to finance capital outlay projects
  - ▶ Issuing new GO Bonds for specific capital outlay projects, which will be paid with E-SPLOST receipts
- ► Funds can't be used for:
  - Day-to-day operational expenses
  - Salaries
  - Personnel
  - Offsetting budget shortages
  - Books or curriculum-based materials

  - Build to GHSA state competition standards
- Athletic improvements District-wide
  - ▶ Upgrades to **all** middle school football/soccer fields including:
    - Field upgrades
    - Scoreboards
    - Goal posts
    - Bleachers
    - Sidewalk safety and accessibility concerns
  - ► New gym bleachers for <u>all</u> middle schools and high school gyms with wooden bleachers
  - Expand weight rooms at Columbus High School and Carver High School
  - ► Kinnett Stadium upgrades including:
    - New LED lighting system
    - New sound and video screen system
  - ► Resurface tracks at Hardaway and Carver high schools



### SUPPORT TO LEARN

- ▶ Replacement of outdated furniture, fixtures, and equipment (FF&E) System-wide
  - Furniture replacement at <u>all</u> schools, where needed
  - Continue to purchase band and orchestra equipment for middle and high schools
- Addressing <u>all</u> facilities needs as reflected in the District's DOE Five-year Facilities Plan
  - Renovations as necessary including:
    - Painting
    - Flooring
    - Lighting
    - Ceilings
    - Plumbing
    - Windows
    - Doors
    - Tack boards and marker boards
    - Energy efficiency
    - Security
    - Classroom and lab casework
  - Modifications as necessary including:
    - Roofs
    - HVAC
    - Awnings/canopies



## SUPPORT TO LEARN

- ▶ Playgrounds
  - Replacement of <u>all</u> playgrounds District-wide
- Campus safety and security improvements
  - Construct additional parking lots, where needed
  - Construct additional sidewalks and stairs to meet safety and accessibility needs
  - Install fencing District-wide to increase safety and security
  - Secure exterior building connectors
- Replacement of outdated buses, vehicles, and transportation equipment
- Replacement of outdated school nutrition equipment
- ▶ Update secondary science equipment and technology


