Portfolio Structure (Should be ongoing for Grade 11 and Grade 12)

- A. Your portfolio should be a **professional** presentation that is a representation of all that you have accomplished in your two years of IB CAS/Service Learning.
- B. Your cover should indicate what the portfolio is, who you are, and perhaps a meaningful quote that is representative of what your IB CAS/Service Learning experience has meant to you.
- C. You should have labeled tabs for every ongoing Experience and one tab for ALL one-time experiences
- D. Sheet with hour totals for C, A, & S This should include what experiences have contributed to each area
- E. CAS/Service Learning Advisor Meeting Documentation Form
- F. Your binder should be divided into Grade 11 and Grade 12 experiences. If you engage in an experience over both years, you need supervisor forms for each year.
- G. Agency Tab
 - i. Agency Proposal Form
 - ii. Agency Supervisor Evaluation Form
 - iii. Agency Log Sheet
 - iv. Agency Reflections
 - v. Agency Artifacts
- H. Ongoing Experience #1 Tab

 - iv. Ongoing Experience #1 Artifacts

CAS/Service Learning Capstone Presentation (@ end of Grade 12)

- For EACH learner outcome, you should demonstrate HOW you met the learner outcome by selecting the BEST example from all of your experiences that shows that you not only met it but also grew as a result.
- Proceed through the presentation one learner outcome at a time
- Include BRIEF speaking points to keep yourself on track
- Include some pictures to give the audience something to see
- Practice your presentation...you're not as good at "winging it" as you think. There is a 10 minute time limit time yourself when you practice.
