### What is Title I?

Johnson Elementary is identified as a Title I school as part of the Every Student Succeeds Act (ESSA). Title I is a federal grant that was designed to ensure that all children receive a high quality education and reach grade level proficiency. Title I programs must be based on effective means of improving student achievement and include strategies to support parent and family engagement.

### **School Plan for Shared Student Achievement**

#### What is it?

### School's Smart Goals

By May 2018, 100% of staff will be trained in Tier 1 School-Wide Positive Behavior Interventions and Supports (PBIS) and at least 5 out of 10 critical elements will be developed to 80% as measured by the Tiered Fidelity Inventory (TFI) and Self-Assessment Survey (SAS).

By May 2018. 100% of teachers will implement strategies to help student process content.
