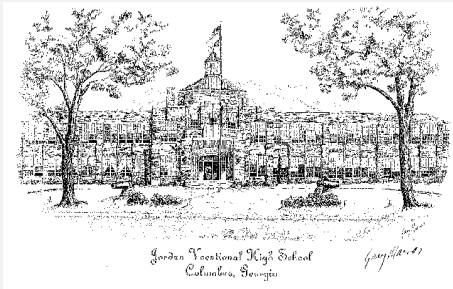

What is Title I?

Jordan Vocational High School is identified as a Title I school as part of the Elementary and Secondary Education act of 1965 (ESEA). Title I is a federal grant that was designed to ensure that all children receive a high quality education and reach grade-level proficiency. Title I programs must be based on effective means of improving student achievement and include strategies to support parental involvement. All Title I schools must jointly develop with all parents a written Parental Involvement Policy.

Parental Involvement Policy for Shared Student Achievement

What is it?

The Parental Involvement Policy describes how Jordan Vocational High School will provide opportunities to improve parent engagement to support student learning. Our school values the contributions and involvement of parents in order to establish partnerships for the common goal of improving student achievement. The Parental Involvement Policy describes the different ways the school will support parent engagement and how parents can be involved.

How is it developed?

Jordan Vocational High School welcomes parent input and comments at any time regarding the Parental Involvement Policy. All parent feedback will be used to revise the plan for next year. We will also distribute a Title I Annual Survey to ask parents for suggestions on the Parental Involvement Policy and the use of funds for parent involvement.

Who is it for?

We will provide full opportunities for the participation of parents with limited English, parents with disabilities, and parents of migratory children.

District Goals

- By 2017, the percentage of students in grades 9th – 12th, scoring Proficient Learner or Distinguished Learner in Math EOC and Reading EOC will meet or exceed the state average as measured by Georgia Milestone Assessment

School Goals

- By 2017, the scores on the Compass Assessment taken by the Freshman class will increase from the pre-test to the post-test
- By 2017, the number of students taking dual enrollment classes will increase by 20%
- By 2017, the number of students graduating will increase from 63.4% to 72.6%
- By 2017, the number of students eligible to receive the HOPE scholarships will increase by 20%

What is a Home-School Compact?

As part of the Parental Involvement Policy, a Home-School Compact for Achievement is an agreement that parents, students, and teachers develop together. It explains how parents and teachers will work together to make sure all our students reach grade-level standards. The compact will be reviewed and updated annually based on feedback from parents, students, and teachers. The Home-School Compacts are kept in the Parent Resource Room.

Jordan Vocational High School will take the following measures to promote and support parents in the following ways:
