Dr. Polleys reported on the showcase in the hall of the Muscogee County Public Education Center and invited the group to be on the look-out for education memorabilia that can be collected to add to the showcase.

Betty Woodruff gave a report on the portraits that have been collected and are being stored in the MCPEC building.

The discussion of the group centered on the collaboration with the Columbus Museum to partner with the MCSD History Committee in presenting a logical education story. In attendance were Mike Bunn, Curator of History at the Columbus Museum and Roger Reeves, Exhibit Production Design Coordinator. Dr. Polleys stated that she has not received the DVD of the St. Elmo project but hopes to have it in the future.

Richard Hyatt gave a report on his efforts to contact the Columbus Ledger-Enquirer regarding the history articles, photographs, etc. that currently exist at the newspaper. Dr. Polleys noted that she, Richard Hyatt, Jim Buntin and Susan Andrews will meet with the newspapers' CEO.

Dr. Buntin gave a report on his progress with Doug Pullen. Mr. Pullen asked that he submit another letter of interest for grant funds. Dr. Buntin will proceed. Dr. Polleys noted that the group should view the Bibb Elementary history on Face book.
