Get Started on Your Project

A National History Day® (NHD) project is your way of presenting your historical argument, research, and interpretation of your topic's significance in history. NHD projects can be created individually or as part of a group. Only the research paper has to be completed as an individual project and it may not be with a group or partner. After reading the Contest Rule Book and learning about the annual theme, you're ready to dig in!

You don't have to choose your topic at this time, unless you want to. Think if you want to work by yourself or with a partner or partners. I do limit the amount of people working as a group. If you need more than one partner, you will have to contact me and explain why you need more than one person helping you doing the research and creating this project. If you are thinking about a performance, I do allow up to five people for this group project. Think about what type of presentation it is you want to do. If you tried an exhibition board in your 7th grade, try something new. Broaden your horizons. Remember this is your project, but I will be working very closely with you when school picks up after the summer break.
