### Areas of Strength

Most staff and students know expectations; students could give an example of a rule in a specific location; school store/events - great use of "free" awards (bathroom passes, Chromebook charge, etc.); great climate and culture.

### Areas in Need of Improvement

Make sure location-specific matrices are posted in locations; make sure students know what they are being acknowledged for - behavior-specific praise; knowledge of Tier 2/3 interventions; work on teacher buy-in.
